#### Firebreaks Policy

Council requires the owners or the occupiers of the land within the shire, exceeding four hectares in area, to make and maintain fire breaks surrounding the entire property or as near as practicable, thereto by ploughing or maintaining bare earth to a width of not less than 3 metres. Such work must be completed by the 31st October as per current advice from RFS.

Where harvesting is carried out prior to the 30th October fire breaks must be established prior to such harvest. Where it is intended to carry out clover harvesting and the clover paddock to be harvested is located on the boundary of a property, landholders are required to establish a fire break by ploughing to a width of not less than 10 metres (33ft) along such boundary

#### **Notice from Rural Fire Services**

The local bush fire danger period currently will be 1st November 2020 until 31st March 2021

As conditions may change, updated information can be obtained from the Local RFS teams.

During this period permits (obtained through the RFS ph) 6971 4500) will be required for the lighting of fire for the purposes of land clearance or fire breaks.

#### **COVID-19 Update On Council Matters**

Council continue to receive advice and updates in relation to the current restrictions relating to COVID-19. In regards to Council run events or public gatherings, this may mean changes to how we operate. This is particularly relevant to Australia Day, NYE street party and public swimming pools. We will endevour to keep the community updated with requirements as they unfold and change due to the COVID requirements.

#### **Local Roads Update - Construction Period**

The reconstruction of 4.87kms of Bygoo Road has been split into two stages. The first stage is underway now and aims to be completed with seal by 20th October, prior to harvest. The second stage is scheduled for February/March 2021.

As construction teams are on the roads, please exercise caution with changes to the road conditions and adhere to traffic control measures in place. Current construction works include;

Bygoo Road - Northern End	Reconstruction works	Commenced
Roping Pole Road	Shoulder widening works	Late September
Deepwater Road	Shoulder widening works	Early October

#### **Pool Safety Requirements**

Make sure your pool is fenced and meets safety regulations, even if it is an inflatable pool.

With summer and the swimming season fast approaching Council recognises the importance of working with the community to promote increased safety for young children around backyard

By law, all pools that can be filled with 30cm of water or more









must have a fence that meets the requirements of the Swimming Pool Act and Regulations, additional safety requirements include (not limited to) updated resuscitation sign, eliminating climbable zones and pool compliant gates. Penalties for not complying have been increased by the NSW Government to \$5,500.

Remember, a pool fence does not mean children are automatically protected - there is no substitute for supervision and vigilance. Make sure you regularly check your swimming pool and fence for faults throughout the year and never take your eyes off children

when they are in or near water.

#### Help Stop Illegal Dumping In Our Community

Council needs your help to stop illegal dumping in our community.

Illegal dumping is the disposal of waste on public or private land or into water without a licence, permit or approval from the relevant authority such as Council or the EPA. It varies from small bags of rubbish in an urban environment to larger scale dumping of materials in isolated areas, such as bushland.

Commonly dumped items include garden waste, building waste, asbestos, household rubbish and household items such as furniture, whitegoods and mattresses.

Illegal dumping is a crime and costs our community thousands of dollars every year, with ratepayers' money used to clean up dumped waste that could be better spent on positive community initiatives. It also contaminates land for our local wildlife, encourages weed infestation in our nature reserves, and looks unpleasant. Those found guilty face fines from \$4000 minimum up to \$1 million.

The Library will be offering a variety of craft and activities packs for our Youth Program and for the Sept/Oct School Holidays.


